- A. WHEREAS the Parties have signed an MOU on 25th October 2018, by which Redington Foundation has agreed to provide its support to the College by providing certain services in the College premises.
- B. WHEREAS the Parties wish to renew and extend the term of the MOU and also include the establishment of Elite Smart Learning Centers by the Redington Foundation for the benefit of the underprivileged students of the College as per the terms mentioned in this Addendum.

Now this Addendum witnesses as follows:

**ELITE SMART LEARNING CENTRE: (Henceforth will be called as Hotspot centers)**

1. Both parties agree that the term of the MOU shall be extended for a period of three (3) years from the Effective Date of this Addendum. i.e. from 14<sup>th</sup> August, 2021 until 13<sup>th</sup> August, 2024.
2. Redington Foundation will continue to support the underprivileged students of the College, by providing training as per the plan scheduled for the current academic year by the Foundation.
3. Redington Foundation will implement the "Online training program" either through an implementing partner/agency who has adequate professional expertise in implementing similar projects OR the Foundation will implement its own course curriculum which will be designed, created and implemented through its own digital platform.
4. Redington Foundation – Online Projects team will send the complete guidance on implementation steps/procedures involved in implementing the project.
5. The student's database as required by Redington Foundation will be shared by the College SPOC with the Foundation, which will enable the Foundation to select the list of

- by the Foundation. The College agrees that it shall inform every student and obtain all necessary consents from the students while sharing the database with the Foundation.
6. Any training program provided by Redington Foundation will be done as part of their CSR activity. If the training involves any reputed brand certifications, Redington Foundation will bear such course fee, however the student/college shall have to bear the examination fees and any certification fees additionally required, since the certification will be provided to only those candidates who have taken up the certification examinations and are declared successful.
  7. The students for Redington Foundation's online training will be selected after carefully examining the eligibility criteria as laid down by Redington Foundation and also after qualifying through an aptitude test.
  8. As per the eligibility criteria, students in second year and final year UG programs are eligible to apply for the trainings, provided they fulfill the following criteria:
    - a) Students should have no arrears in their previous semesters
    - b) Students should have an average of 60% or equivalent CGPA from all previous semesters.
    - c) Students should belong to the category where family annual income is less than Rs. 300,000/-.
    - d) Students eligible as per above criteria will appear for an aptitude test conducted by Redington Foundation and should score above 60% marks.
  9. Redington Foundation will use the database provided by the College, only for the purpose of selection of students for Online Learning programs and will protect student's privacy and will not share the information contained in the database with any third party in any manner, without the concurrence of the College in writing.
  10. Redington Foundation reserves the right to select the students through its own selection criteria, as indicated in point (7) above. The selected students will attend the Online Learning Programs through a combination of self-paced learning, direct classroom sessions with lab and webinars by academic/industry experts to be organized by Redington Foundation.

11. For attending the classes online by self-paced learning, the students should have Android smart mobile phone /Laptop/Desktop.
12. The students will have the option to also utilize the computer lab with the permission of the college management that will be set-up in the College as prescribed by Redington Foundation to the college management.
13. The students will attend the Online Learning Program through self-paced learning and the attendance will be tracked by Redington Foundation on regular basis. The attendance of the student will also be shared with the College.
14. Redington Foundation has provided 25 desktop computer systems with suitable specifications as required for conduction of the prescribed curriculum of the offered subjects of study under the Online Program. The specifications of the desktop computers are as follows:

d. In case of any claims arising on account of Redington Foundation entering into this Addendum, College shall irrevocably indemnify Redington Foundation and ensure that the Foundation does not incur any liability on account of the same.

39. This Addendum as well the MOU shall be governed by the laws of India. Any dispute under this Agreement shall be referred to arbitration under the Arbitration and Conciliation Act 1996 or any statutory modification, recent enactments as may be then in force. The arbitration shall be conducted by a sole arbitrator. The arbitration proceedings shall be conducted in Chennai and Chennai shall be the principal seat and venue for Arbitration. The language of Arbitration shall be English. This addendum will become an integral part of the original MOU, from the date of execution of this Addendum by the Foundation.

The MOU is incorporated by reference into this Addendum and except as specifically mentioned herein, all terms and conditions of the MOU will remain unchanged and in full force and effect.



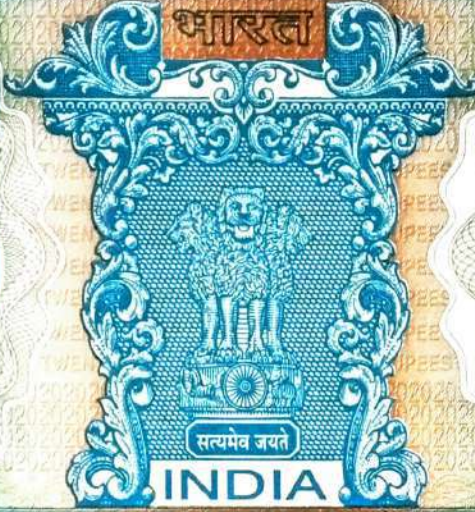

### CAMPUS CONNECT AGREEMENT

This Agreement (the "Agreement") is made on this, the **Eleventh day of December 2019**, (the "Effective date")

**by & between**

PS ACADEMY, having its office at 42, Annanagar, Dindugal, 624005, and represented by its Managing Director Mr. APF.SUSHEEL, aged 43 years, son of Mr. M.ROCKIASAMY, being party of the First Part, hereinafter referred to as the "Franchisor", (which expression unless excluded by or repugnant to the subject or the context shall mean and include its legal representatives, successors, and assigns of the First Part).

**AND**

THE MANAGEMENT, SRI SARADA NIKETAN COLLEGE OF SCIENCE FOR WOMEN, KARUR, being party of the Second Part hereinafter referred to as the "Franchisee", (which expression shall, unless excluded by or repugnant to the subject or the context shall mean and include its successors and permitted assigns of the Second Part);



## RECITALS

WHEREAS the Franchisor has developed and continues to develop and owns a Training academy specializing in Life skills, language skills and personal development under the trademark PS ACADEMY. This includes without limitation, the concept, the logos, the trademarks, commercial announcements (slogans) and the operating methods, rules and regulations revised from time to time,

AND WHEREAS the Franchisee is having satisfied itself about the goodwill and technical and management capabilities of the Franchisor has entered into this agreement with the Franchisor for availing a franchising license to operating a PS ACADEMY

AND WHEREAS the Franchisor has agreed to grant the Franchisee the right to open the Franchised Training Centre

NOW THEREFORE the Franchisor and Franchisee, in consideration of the mutual promises and covenants contained herein, agree as under

## Definitions

- 1.1. "Intellectual Property" shall mean and include, all copyrights, patents, patent applications, trade secrets, the Business Format or other intellectual property rights of the Franchisor in, upon or in relation to the Trade Marks, Business Format, the Proprietary Software, which are all exclusive and proprietary to Franchisor and any of the content or matter or form of decoration, presentation available, and to be made available at any time and from time to time at the outlet, whether pursuant hereto or otherwise.
- 1.2. "Franchised Training Centre" shall mean the Training Institute duly authorized by the Franchisor under this agreement
- 1.3. "Opening Date" shall be the date of opening of the Franchised Training Centre
- 1.4. PS ACADEMY the exclusive Trademark/Brand of the Franchisor which is engaged in the business of offering training centres specializing in training facilities, including exclusive training services, related services and ancillary related activities as we may authorize periodically under the trademark
- 1.5. "Trademarks"/Trademark/Trade Marks shall mean the various trademarks, service marks, trade names, logos, slogans, trade dress, commercial symbols, whether registered or not of the Franchisor.

## CONSIDERATION AND CONDITIONS

### 1.1. LICENSE GRANT FOR FRANCHISEE

- 1.1.1. The Franchisor grants to the Franchisee the exclusive right to set up a Franchised Training Centre at Sri Sarada Niketan College of Science for Women, Karur. Under the trademark "PS ACADEMY" as per the standards maintained by the Franchisor along with the license to use the Trademark against the Franchised Training Centre during the term of this Agreement only.

- 1.1.2. The Franchisee shall not have any right to set up and/or operate training centres or provide training under the Franchisor Trademarks other than at the approved location provided here

## 1.2. CONDITIONS

- 1.2.1. Franchisee will keep the Franchised Training Centre open for business on mutually agreed upon timings.
- 1.2.2. Franchisee will obtain and use all support material required by Franchisor and will refrain from using any support material or not approved by Franchisor.
- 1.2.3. Franchisee will use only Franchisor's approved method of instruction in all sessions and classes.
- 1.2.4. The Franchisee shall operate the Franchised Training Centre for customers ranging from an age group of 8 to 60 years. With regard to the trainees of age 8 years to 15 years, the Franchisee should obtain necessary consent from the natural/legal guardian before enrolling the trainee. The Franchisee should maintain proper records of the enrolment forms of all the trainees and make submissions of the same to the Franchisor in every 30 days or as and when required by the Franchisor.
- 1.2.5. The Franchisee shall not include in its Franchised Training Centre any mode of training other than those approved by the Franchisor. Any inclusion of unapproved training equipment in the Franchised Training Centre will tantamount to be a qualifying reason for the Franchisor to terminate this agreement without any prior notice.

## Consideration

- 2.1. It is clearly understood and agreed between the parties hereto that the Franchisee alone shall be responsible for financing the setting up of and operating the said Franchised Training Centre.
- 2.2. It is hereby agreed between the Parties that the Franchisee shall be liable to pay Franchise Fees being an amount of (20% of total billing from the In-house programs offered) per month, from and including the first month of the date of inauguration of the Franchised Training Centre. This amount is exclusive of all applicable statutory deductions, taxes, levies and discounts if any applicable.
- 2.3. The Franchise fee mentioned is payable by the Franchisee to the Franchisor as per the terms mentioned in the said clause until the end of the Fifth year from the Opening date as per the terms of the Franchise agreement. On completion of the fifth year, the said Franchise fee will be reconsidered and renegotiated by both the parties.
- 2.4. All amounts due and payable by the Franchisee to Franchisor shall be paid by the 7<sup>th</sup> of each month. Without prejudice to any remedy available to the Franchisor under this Agreement or under the law, if the delay continues beyond 2 (two) months then the Franchisor Party can terminate this Agreement with 7 (seven) days' notice to the Franchisee.

#### OWNERSHIP:

- 3.1. Except for right to the use of the Licensed Rights and the Trade Mark License as expressly outlined in this Agreement nothing in this Agreement shall constitute or be construed as the acquisition of any ownership interest, title, or legal or moral right by the Franchisee to the Intellectual Property Rights of the Franchisor in or upon or in relation to any of the content or matter or form of decoration, training techniques, made available at any time to the Franchised Training Centre whether pursuant hereto or to any other agreement or arrangement.
- 3.1.1. The personnel employed by the Franchisee shall be on Franchisee's roll and the Franchisee shall be responsible for the timely payment of salary to its employees and shall alone be liable for complying with the labor laws and other legislations as are in force and / or applicable from time to time.
- 3.1.2. Under no circumstance, the Franchisor shall have employer and employee relationship either direct or indirect, with the employees employed / engaged by the franchisee.
- 3.1.3. That the Franchisee shall only display such advertisements, flyers, handouts, brochures, or any other form of promotional material as shall have been indicated or approved or provided by the Franchisor at each of the Franchised Training Centres. The expenses for such advertisement, sales promotion shall be the sole responsibility for the Franchisee.
- 3.1.4. That the Franchisee shall not publicize the Franchised Training Centre through any means and using any materials without the prior written approval of the Franchisor and the Franchisee specifically undertakes to provide all materials to be utilized with respect thereto, whether printed or otherwise, to the Franchisor for approval prior to displaying or utilizing the same.
- 3.1.5. That the Franchisee shall not display or permit or suffer the display of any brand names, trademarks, other identifying marks of any person or any sign or other medium of display or advertisement at the Franchised Training Centres without the prior written consent of the Franchisor.

#### INDEMNITY

- 4.1. The Franchisee hereby indemnifies and hold harmless the Franchisor, its partners and its agents, employees, consultants and Representatives from and against any and all losses, claims, customer complaints, liabilities, judgments, damages and other matters, including but not limited to, reasonable attorney's fees arising out of or incurred in connection with, a breach of any representation, warranty, violation of the terms of the lease with the landlord or covenant of the Franchisee under this Agreement or under applicable Laws or rules or regulations whether implied or expressed.



## TERM AND TERMINATION

### 5.1. Term and Renewal

5.1.1. The Parties agree that the Term of this Agreement shall be a period of 5 years from the Effective Date or unless terminated earlier by either Party pursuant to the provisions of this Agreement.

5.1.2. This Agreement shall be renewable for a further term of 5 years by the Franchisor.

### 5.2. Termination

5.2.1. Franchisor may terminate this Agreement during the Term if the Franchisee fails to comply with any undertaking, term or condition of this Agreement, so long the Franchisor has given the other a written notice of such failure and the Franchisee has not remedied such failure, or has not taken reasonable steps to timely remedy such failure, within a period of one eighty (180) days from the date of the notice which shall be the cure period specified in the written notice of termination.

5.2.2. The Franchisor may terminate this Agreement by giving 30 days' notice to the Franchisee in the event:

(a) the Franchisee is declared bankrupt, or

(b) the Franchisee or any of its partners/trainers are involved in any criminal act or declared / prosecuted / involved in any criminal act or case which would be prejudicial to the interest of the Franchisor herein.

### 5.3. Procedure upon Termination or Expiry of the Agreement

5.3.1. Upon termination or expiration of this Agreement for any reason, the Franchisee's right to use the licensed rights and the business format will terminate immediately.

5.3.2. Termination of this agreement under any circumstances shall not abrogate, impair, release or extinguish any debt, obligation, or liability of franchisee to franchisor or franchisor to franchisee, which may have occurred hereunder.

MEMORANDUM OF UNDERSTANDING  
BETWEEN

**Article I**

In compliance with the prevailing rules and regulations, an academic/research collaboration between Sri Sarada Niketan College for women, Karur, Tamil Nadu, India and National College (Autonomous), Tiruchirappalli, Tamil Nadu, India. This protocol agreement is entered into the recognition of the joint benefits that can be derived from a program addressing problems of common interest and mutual consent.

**Sri Sarada Niketan College for Women**, an institution of Higher Education and Research affiliated to the Bharathiyar University with its Campus at Esanatham Road, Kodangipatti, Karur - 639 005.

**National College (Autonomous), Tiruchirappalli**, an institution of Higher Education and Research affiliated to the Bharathidasan University with its Campus at Dindigul Road, Tiruchirappalli-620 001.

Whereas parties desirous of establishing cooperative relations between them, especially in research and development related technologies and transfer of the same between parties, agree as follows:

## **Article II**

### **OBJECTIVES**

The objectives of the parties are:

1. Identify areas of academic collaboration for sharing of best academic practices prevailing among the teaching departments.
2. Use of Human Resource for sharing of expertise and visiting professorships.
3. Identify and work on research projects mutually agreeable.
4. Submit joint proposals to funding agencies like DBT, DST, BIRAC etc. with mutual consent.
5. Joint publications and books with equal contribution by both institutions.
6. Conduct of periodic conferences/workshops both online and offline
7. Organize student centric activities

## **Article III**

### **SCOPE OF COOPERATION**

- ✓ Both the institutions have a long standing legacy in teaching and research. Through this memorandum of understanding the parties agree to cooperate in a beneficial pattern so as to refine the curriculum from time to time by sharing of best practice and experiences, and enable joint research and publications. The two parties also agree to organize National / International level joint workshops/symposia and seminars which will be relevant to both the institutions.



- ✓ Each research project will be identified on mutually agreed basis from above mentioned focus area and detailed terms & conditions like scope of research, detailed budget, implementation of research & its time line will be spelt out as agreed mutually from time to time between National College and Sri Sarada Niketan College for women.

#### **Article IV**

Publication of all joint projects and their outcomes are allowed and are free of charge for both parties. Author's copyright and patent protection rules and regulations are to be observed by both parties. National security concerns should also be taken into consideration in publication and dissemination of the subject materials. Both the parties also agree to co-own any Intellectual Property (IP) Rights generated out of the cooperative work and shall not amend / modify / transfer the IP to third party unless mutually agreed upon.

#### **Article V**

In order to achieve the objective stipulated in this agreement, the contracting parties agree to organize the planned activities in accordance with the discussed articles and the rules and regulations effective in the respected institutions.

1. The contracting parties shall determine the required processes, methods and necessary budget and shall periodically discuss and implement them.
2. Both parties shall undertake to explore some financial resources to achieve the objectives stipulated in this agreement.

Financial resources would be essentially internal funds or budgets allocated for the purpose of working together on joint initiatives, or Govt. supported funds for R&D activities of funds accrued from Startup Accelerators.

#### **Article VI**

The above-mentioned areas are gist of the areas identified for cooperation at present and extent of cooperation and the amount of assistance will be mutually decided by the parties from

time to time. Parties are at liberty to revoke / cancel this understanding by giving 30 days notice. Any IP generated on the product / process, publications and other such research findings shall be co owned by both the parties even after the termination of this understanding.


## Article VII


